PREVENTION & EDUCATION

HTDPC 2025 Town Hall - In partnership with SpiritWorks Foundation, the HTDPC hosted two free screenings of *Together: Family Recovery*, a documentary sharing the powerful stories of three families impacted by addiction. Both events were well received with 82 people in attendance. The Sept. 25 screening featured a panel with film participants Karen McFarland, her granddaughters Adryan and Angel, Co-Director/Producer Shelly Young, and Jan Brown, Executive Director of SpiritWorks Foundation. Both screenings concluded with a call to action to carry forward the film's message.

POLICY & LEGISLATIVE ADVOCACY

Through the Miss Virginia School Tour, and in partnership with Virginia ABC, Miss Virginia visits elementary schools across Virginia to promote health, wellness, and substance use prevention. During these visits, she encourages students to make healthy choices and raises awareness about the dangers of substance use. Her message supports positive decision-making and aligns with the Virginia Standards of Learning (SOLs), specifically focusing on advocacy, health promotion, essential health concepts, and healthy decision-making related to substance use prevention.
